**RECOMMENDATION**

Discussion of approving a contract with Prescription Pools and Spas, L.L.C. for testing and servicing of the Navarre Park splash pad.

**BACKGROUND**

The Navarre Park splash pad operates from May 1<sup>st</sup> through September 30<sup>th</sup>, each year. The operation of the splash pad requires the services of a certified pool technician to be in compliance with FAC Chapter 64E-9. Our previous service provider, Mermaid Pools and Spa, declined to renew their contract. The proposal from Prescription Pools and Spas, L.L.C. was the only response received for the services. Upon review of the proposal, and through conversations with the company representative, we are confident that the operational and maintenance requirements of the state can be achieved through the contract with this provider.
