

**RESOLUTION NO. 2018 - 09**

**BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS  
OF SANTA ROSA COUNTY, FLORIDA,**

**SECTION 1.** The following procedures and rental fees are adopted for County owned properties which are available for rental:

1. Procedure for rental of County owned property:

- Full payment is required before a reservation can be held.
- Recurring reservations may be held with a non-refundable deposit equal to the amount of one rental fee; such reservations must be paid in full or cancelled 14 days prior to the event date.
- There is a minimum 3-hour rental requirement.
- Normal operating hours are Sunday through Saturday, 7:00 a.m.-10:00 p.m. Use beyond normal operating hours requires county administrator approval and will incur an additional \$5 per hour fee in addition to the regular hourly fee for each hour before or after normal operating hours.
- Sale, serving or consumption of alcoholic beverages is allowable only with approval of the Board of County Commissioners for commercial events or by designated staff for non-commercial social events. Alcoholic beverage sales or consumption at commercial activities by entities other than IRS approved not for profit organizations, including but not limited to concerts, entertainment shows, and the likes will not be approved. An administrative fee of \$35 will be assessed to applicants for alcohol variances.
- Tax will be added for all rentals except for non-profit organizations with DR-14.
- Fee for pavilions not listed below: \$35 per day.
- Fee for Run/Walk Events: \$100
