MINIMUM SPECIFICATIONS

SKID STEER LOADER

The following specifications describe the **minimum** (unless noted) requirements for a skid steer loader. The equipment bid shall be new, equipment manufactured the same year or succeeding year of the bid, of a current design and production model, and available to the commercial market. Any

additions, deletions or variations from the following specifications must be noted. Standard items appearing in the manufacturer's published specifications furnished by the bidder shall be included in the bid unless otherwise noted. One copy of the manufacturer's published specification shall be included with the bid.

General:

1. The skid steer loader shall be a regular production model for which published specifications are available.
2. Machine modifications to meet the operation requirements of this specification shall be limited to the manufacturer's published standard and optional equipment.
3. All operating specifications are based on current SAE standards and shall be the basis for determining compliance with specified requirements.
4. The skid steer loader shall have a 3,000-pound rated operating capacity.
5. The skid steer loader shall have a maximum weight (without attachments) of 9,400 pounds.
6. The skid steer loader shall meet all OSHA and EPA requirements in effect on the date of bid opening and shall have lead free paint.

Engine:

The skid steer loader shall have a minimum of 4 cylinder, diesel engine with a 82 net horsepower. The engine shall provide a minimum SAE net torque rating of 260 ft-lbs at 1400 RPM.

The engine also shall have the following:

- Turbo Charged
- Internal oil cooler
- Integral water pump
- 12-volt electrical system
- 90-amp alternator
- Single serpentine belt for fan and alternator
- Automatic self-adjusting belt tensioner
- 250-hour engine oil change interval
- Approved federal emission regulations.

Hydrostatic Transmission:

The power train shall be hydrostatic drive.

The hydrostatic drive shall also provide the following:

- Tandem axial piston with integral charge pump
- Hydrostatic pumps that are directly driven off the engine flywheel
- Servo-controlled hydrostatic pumps
- Heavy duty drive motors
- Spring applied, hydraulic release disc parking brake (SAHR)
- Independent push-button parking brake.

Chain Case:

The skid steer loader shall have a heavy-duty chain case with ASA 120HS Chain.

Tires:

12x16.5 foam filled slick.

Loader and Linkage Features:

The loader arms shall be a heavy-duty box section, vertical lift linkage geometry design, w/auxiliary hydraulics and quick disconnect couplings.

Attachments:

1. Bucket:

The loader bucket also shall have the following features:

- Pre-drilled holes for cutting edge
- Built-in step on the top of the bucket
- Capability to be used on other skid steer loaders of same manufacturer
- 82" Light material, 26.1 cuft struck, 32.5 cuft. heaped.

2. Pallet Fork:

The pallet forks shall be of a heavy-duty design with 48" forks that are manually adjustable for narrow or wide loads.

Pallet forks shall have the following features:

- Minimum fork length 48"
- Forks must be manually adjustable so as to adjust for wider or narrower loads.

Operator Environment:

The operator compartment shall be accessible from the front of the machine.

The operator compartment shall also have the following features:

- Flat floor plate with foot rests
- Suspension seat
- Left and right-hand controls for skid steer travel and steering
- Right-hand control for bucket operation
- Left-hand control for loader operation
- Operator restraint bar with gas assist cylinders
- Operator restraint bar that when raised, engages the parking brake and neutralizes transmission
- Operator restraint bar that when raised, locks out the loader lift arms and bucket controls
- Monitoring system with LED lights and audible alarms for vital machine functions
- Bar graph fuel gauge that flashes on reserve
- Parking brake that is controlled by the restraint bar, push button, engine shutoff, neutralized controls.

Performance:

The skid steer loader performance shall include the following minimum (unless noted) requirements:

- Maximum height to the top of the ROPS of 83 inches
- Maximum height to the hinge pin of 127 inches
- Dump height with loader arm at maximum of 95 inches
- Reach with bucket at full height of 32 inches
- Tipping load capacity of 6,000 pounds
- Cycle time raising the loader arms with rated load of 4.4seconds.

Serviceability:

The skid steer loader shall be easy to service from ground level. All daily check points shall be in one location.

Service access to the engine, power train and hydraulic system shall be with out tools.

The skid steer loader service also shall include the following:

- 20-gallon (min.) fuel tank with the fill location at the back of the machine
- 16.5 (min) total gallon hydraulic oil system
- Hydraulic oil sight gauge
- Swing-out oil cooler.

Warranty:

The skid steer loader warranty shall be clearly stated for engine, power train, and other components. Warranties shall be at least one year base, 2 year/2000 hours on engine. Service Dept. must be located in the State of Florida within 50 miles of zip code 32570.

Manuals:

Successful bidder shall supply two (2) copies each of the operation, manual, and (1) one copy each of parts, and shop manuals.

I understand that a "public entity crime" as defined in Paragraph 287.133(1)(g), Florida Statutes, means a violation of any state or federal law by a person with respect to and directly related to the transaction of business with any public entity or with an agency or political subdivision of any other state or with the United States, including, but not limited to, any bid or contract for goods or services to be provided to any public entity or an agency or political subdivision of any other state or of the United States and involving antitrust, fraud, theft, bribery, collusion, racketeering, conspiracy, or material misrepresentation.
3. I understand that "convicted" or "conviction" as defined in Paragraph 287.133(1)(b), Florida Statutes, means a finding of guilt or a conviction of a public entity crime, with or without an adjudication of guilt, in any federal or state trial court of record relating to charges brought by indictment or information after July 1, 1989, as a result of a jury verdict, nonjury trial, or entry of a plea of guilty or nolo contendere.
4. I understand that an "affiliate" as defined in Paragraph 287.133(1)(a), Florida Statutes, means:
1. A predecessor or successor of a person convicted of a public entity crime; or
 2. An entity under the control of any natural person who is active in the management of the entity and who has been convicted of a public entity crime. The term "affiliate" includes those officers, directors, executives, partners, shareholders, employees, members, and agents who are active in the management of an affiliate. The ownership by one person of shares constituting a controlling interest in another person, or a pooling of equipment or income among persons when not for fair market value under an arm's length agreement, shall be a prima facie case that one person controls another person. A person who knowingly enters into a joint venture with a person who has been convicted of public entity crime.
5. I understand that a "person" as defined in Paragraph 287.133(1)(e), Florida Statutes, means any natural person or entity organized under the laws of any state or of the United States with legal power to enter into a binding contract and which bids or appeals to bid on contracts for the provision of goods and services let by a public entity, or which otherwise transacts or applies to transact business with a public entity. The term "person" includes those officers, directors, executives, partners, shareholders, employees, members, and agents who are active in management of an entity.
