Minimum Specifications Daily Landfill Cover Machine

Description:

The specifications are intended to describe a trailer mounted landfill cover machine with a pintle ring hitch. The machine must be constructed of all new components and must be the latest production model of the manufacturer.

Engine:

The engine shall have a minimum of 45 hp, diesel powered, water cooled. Engine shall have a low oil pressure, high water temperature shut off. Fuel tank shall have a minimum of 15 U.S. gallons.

Tank:

Tank shall have a minimum of 1,000 gallon working capacity. Shall be constructed of 3/16" steel with an epoxy resin coating on the inside. Top shall be raised for easy loading.

Agitation System:

Shall have a complete & thorough mechanical agitator system on primary shaft with direct chain and belt drives, and shall have ball-bearing supported shafts. All re-circulation lines to be a minimum of 1 1/2" in diameter. Have four spray nozzles with quick couplers.

Controls:

All systems shall be operable from upper control panel. Duplicate controls for clutches at ground level.

Pump:

Shall be a positive displacement pump mounted lower than bottom of tank for easy emptying. All connections to pump from tank must be straight.

Axles:

Shall be spindle hub axles with flotation type tires.

Manuals:

A parts and engine manual must be supplied.

Warranty:

One year parts and labor on engine. Two year parts and labor on machine.

4. I understand that an "affiliate" as defined in Paragraph 287.133(1)(a), Florida Statutes, means:
1. A predecessor or successor of a person convicted of a public entity crime; or
2. An entity under the control of any natural person who is active in the management of the entity and who has been convicted of a public entity crime. The term "affiliate" includes those officers, directors, executives, partners, shareholders, employees, members, and agents who are active in the management of an affiliate. The ownership by one person of shares constituting a controlling interest in another person, or a pooling of equipment or income among persons when not for fair market value under an arm's length agreement, shall be a *prima facie* case that one person controls another person. A person who knowingly enters into a joint venture with a person who has been convicted of public entity crime.

I understand that a "person" as defined in Paragraph 287.133(1)(e), Florida Statutes, means any natural person or entity organized under the laws of any state or of the United States with legal power to enter into a binding contract and which bids or appeals to bid on contracts for the provision of goods and services let by a public entity, or which otherwise transacts or applies to transact business with a public entity. The term "person" includes those officers, directors, executives, partners, shareholders, employees, members, and agents who are active in management of an entity.
