Re: RENTAL OF ARTICULATED DUMP TRUCK FOR CENTRAL LANDFILL

---

### Discussion:

The SRC Central Landfill has recently completed construction of a new MSW disposal cell. Environmental Department staff is currently preparing to place the first 3' layer of waste within the cell as soon as the cell is certified by FDEP, which should be the end of April, 2016. The first layer of waste must be carefully selected to make sure there are no sharp objects such as treated wood or pieces of metal mixed in the MSW that could potentially puncture the liner. This will mean that for an approximate 3 month period the Landfill will have a total of three (3) working faces, (Class I Select Loads, Class I Normal Loads, and Class III).

### Finding:

During preparation to begin depositing select loads into the new disposal cell it was noted that the landfill only has one articulated dump truck, and it will not be able to handle hauling daily cover to the Class I select load area, Class I normal load area, the Class III area, and haul soil for slope maintenance. In addition, landfill staff needs to perform maintenance on the entrance/egress road for the new cell which will involve hauling additional soil and aggregate to this road and spreading/compacting for stabilization during heavy rain events. Environmental Department staff solicited quotes from three (3) local companies for the monthly rental of a 25-30 ton articulated off-road dump truck (See Attached Quotes for Comparison Shopping). Beard Equipment provided the lowest priced quote which came to \$8,100.00 per month.

### Actions to be Considered:

That the Board of County Commissioners (BOCC) will allow the SRC Environmental Department to rent a 25 Ton Articulated Off Road Dump Truck from Beard Equipment for \$8,100.00 per month for a total of three (3) months. The total for all three months including delivery and pickup charges will be \$24,550.00, based on comparison shopping.


