RECOMMENDATION

Discussion of resurfacing the following roadways in District 4 at an estimated cost of \$42,796.00.

Summit Drive from PGA Blvd. to Cypress Point Circle	\$19,825.00
Cypress Point Circle	\$22,971.00

BACKGROUND

Commissioner Rob Williamson requested that we reserve 20% of his paving budget for the possible construction of sidewalks in his district. This reservation of funds was contingent upon receipt of a legal opinion as to whether the gas tax revenues could be used in this manner. A legal opinion was obtained that deemed sidewalk construction as a non-allowable use of the road paving funds. Summit Drive and Cypress Point Circle are deemed by the Road & Bridge Dept. to be the most logical candidates for the remaining District 4 resurfacing money. Comm. Williamson initially objected to the inclusion of Summit Drive on the list of roads to be resurfaced because he lives on Summit Drive; and he didn't want citizens to think that he had influenced the recommendation of this road. I assured him that we did not know that he lived on Summit Dr. when we conducted our road ratings for this district, and that Summit Drive is our recommended candidate for resurfacing according to our rating system.
