MINIMUM SPECIFICATIONS
Track Type Tractor with Waste Handling Package

GENERAL:

Currently advertised standard production track-type tractor.

WEIGHT:

ASIC operating weight of tractor shall not be less than 44,000 lbs. (includes lubricants, coolant, full fuel tank, blade with trash rack with tilt cylinder, replaceable cutting edge, 22 inch shoes, ROPS canopy, full track roller guards, hydraulic controls, drawbar and operator).

ENGINE:

Six cylinder, in-line configured engine with hydraulically actuated electronic fuel injection.

Gross power of machine shall be at least 175 h.p.

Net power of machine shall be at least 165 h.p.

Engine ratings at 1900 rpm.

Machine shall be equipped with a 24-volt electrically starting and operating system.

Fuel tank capacity shall not be less than 90 gal.

TRANSMISSION:

Shall be a planetary type power shift with torque divider.

Shall provide at least three speeds forward and three speeds in reverse to include 'or hydrostatic drive'.

Shall have a differential steering system.

Shall have an auto-shift and auto kick-down features available.

FINAL DRIVES:

Shall be elevated or incorporate sprocket protection system.

UNDERCARRIAGE:

Shall have center tread idler.

Shall be equipped with trapezoidal shoes.

Shall have lifetime lubricated track rollers.

Shall have sealed and lifetime lubricated idlers.

Shall have bolt-on, replaceable sprocket segments.

HYDRAULICS AND CONTROLS:

Hydraulics and controls shall have a load sensing, variable displacement piston pump which adjusts hydraulic flow to match implement demands.

INSTALLATION:

The waste handler arrangement shall be installed at the original manufacturer's facility.

WASTE HANDLING GUARDS:

The guarding package shall include guards for the final drives and the idler seal.

The idler seal shall have guards to help prevent fire.

The chassis shall have guards to help protect the engine compartment.

The guarding package shall include guards for the radiator (heavy duty hinged).

The guarding package shall include guards for the fuel and hydraulic tank.

The guarding package shall include guards for the crankcase.

LIGHTS:

A front and rear lighting package.

RAISED PRESCREENER:

The machine shall be equipped with a raised pre-screener.

ALTERNATOR (HIGH CAPACITY):

Machine shall have a ducted alternator (high capacity) which is at least 95 amp.

ENGINE ENCLOSURES:

The machine's engine enclosures shall consist of perforated hood and side panels.

REQUIRED EQUIPMENT:

Turbine air pre-cleaner shall remove large particles from the incoming air before they reach the air filter, thus extending filter life two to four times.

Laminated thermal shields shall cover the exhaust stack inside the compartment, hot-side of the turbocharger and the exhaust manifold.

Machine shall have an ejector fan which provides curled trailing edges of fan blade to catch and eject debris readily away from the radiator core.

ROPS mounted air conditioner condenser and fans shall be relocated from the engine compartment to the ROPS to reduce debris and plugging.

OTHER:

Machine shall be equipped with landfill Blade, complete with trash rack.

A trapezoidal track shoe.

Sealed engine side doors.

Hydraulic oil temperature gauge.

Trash core radiator which provides additional cooling capacity over standard equipment.

Front pull hook, rigid drawbar with pin.

Unit shall be equipped with safety switches to stop engine without damage in the event of low engine oil pressure or high water temperature.

A complete set of operator, parts, and shop/repair manuals shall be included.

Station shall be SAE ROPS/FOPS certified.

Station shall be a fully enclosed cab with climate control heating and air-conditioning.

Station shall have a fully electronic display monitoring system for all vital machine functions.

The standard manufacturer's warranty shall be stated and a copy of this warranty attached. The bid price shall include a five-year (7500 hour minimum) extended warranty equal to the manufacturer's standard warranty. The terms and conditions of this warranty shall be attached.

Successful bidder shall provide one copy of operator's manual and one copy of current parts and shop repair manuals.

Since the continuous operation of this crawler dozer is important and sometimes of an emergency nature, it is necessary that the successful bidder shall maintain and/or have access to parts inventory within 100 miles of Milton, Florida. Said parts inventory shall be of sufficient size and variety to offer a level of parts availability of 95% within 48 hours from the time of order by customer. Availability of normal maintenance items such as filters, vee belts, hydraulic lines and hoses shall not exceed 24 hours. Bidder shall attach his proposed program for parts and service availability for evaluation. Review of the bidder's ability to provide prompt parts and service will be used in determining log, qualified bidder. Transport of the dozer for warranty repair shall be the responsibility of the seller.
