## **Minimum Specifications Straight Mast Forklift**

**1. General:**

The specifications are intended to describe a Rubber tire straight mast forklift. The machine must be new, unused, and the latest production model of the manufacturer. The unit must have a minimum operating weight of 15,000 pounds.

**2. Engine:**

A diesel engine, with no less than 80 horse power.

**3. Transmission:**

Four speed, synchronized in all gears with hydraulic reverser. Two Wheel Drive.

**4. Electrical System:**

Voltage: 12 volt.  
Alternator: 65 amp.  
Battery Rating: 950 CCA. 190 Minute Reserve.

**5. Lights and Alarms:**

Turn signals, road and work lights, and backup alarm.

**6. Controls:**

Front Wheel Drive, direction and speed range controlled by shuttle lever and foot pedal controlling engine RPM.

**7. Performance:**

Minimum lift capacity 7000 lbs, Minimum load at maximum reach 3000 lbs, Minimum load at maximum height 7000 lbs.

**8. Delivery Time:**

Delivery time should be stated, but is expected within six weeks of order.

**9. WARRANTY:**

Manufacturers standard warranty should be clearly stated. Responsibility for transportation of the machine or in-field service during warranty periods shall be the responsibility of the bidder. In addition to the manufacturer's standard warranty, bidder is asked to submit a bid for a minimum of 4 additional years, warranty of the power train. Items included in power train warranty, should be clearly stated. If during warranty period the machine cannot be repaired to full operating status within 72 hours a replacement machine shall be provided by the bidder at no cost to the county.

**10. MANUALS:**

Successful bidder shall provide two copies of Operator's Manual and two copies of current parts and repair manuals.

3. I understand that "convicted" or "conviction" as defined in Paragraph 287.133(1)(b), Florida Statutes, means a finding of guilt or a conviction of a public entity crime, with or without an adjudication of guilt, in any federal or state trial court of record relating to charges brought by indictment or information after July 1, 1989, as a result of a jury verdict, nonjury trial, or entry of a plea of guilty or nolo contendere.

4. I understand that an "affiliate" as defined in Paragraph 287.133(1)(a), Florida Statutes, means:  
1. A predecessor or successor of a person convicted of a public entity crime; or  
2. An entity under the control of any natural person who is active in the management of the entity and who has been convicted of a public entity crime. The term "affiliate" includes those officers, directors, executives, partners, shareholders, employees, members, and agents who are active in the management of an affiliate. The ownership by one person of shares constituting a controlling interest in another person, or a pooling of equipment or income among persons when not for fair market value under an arm's length agreement, shall be a prima facie case that one person controls another person. A person who knowingly enters into a joint venture with a person who has been convicted of public entity crime.

I understand that a "person" as defined in Paragraph 287.133(1)(e), Florida Statutes, means any natural person or entity organized under the laws of any state or of the United States with legal power to enter into a binding contract and which bids or appeals to bid on contracts for the provision of goods and services let by a public entity, or which otherwise transacts or applies to transact business with a public entity. The term "person" includes those officers, directors, executives, partners, shareholders, employees, members, and agents who are active in management of an entity.
