## **SCOPE OF WORK:**

The successful bidder will be responsible for the removal of all seating and furniture in order to install the carpet and their replacement/reinstallation of said after installation. An Inspection by the Maintenance Director or his designee will be done to assure all seating is correctly reinstalled before payment is made.

The successful bidder will also be responsible for removing all existing, glued down carpet, removing it from the job site and preparing the surface for the installation of the new carpet to meet the manufacturer's specifications. This includes the removal and replacement of all existing trim and carpet reducers as necessary to return the site to the existing condition.

It will be the responsibility of the successful bidder to schedule the removal and installation of the carpet to coincide with the court case load. It will be necessary to coordinate this action with the Building Maintenance Director or his designated representative.

The color of the carpet will be selected after the purchase order is issued to the successful bidder.

## **Warranty:**

A statement of warranty is required with this bid. The following information must be supplied:

- 1— Copy of Manufacturer's Standard Warranty Policy.
- 2— Copy of any additional manufacturer or dealers warranty policy.
- 3— Name and location of responsible party for processing warranty claims.
- 4— Name and location of responsible party for actual warranty repairs.
- 5— Normal response time to effect repair or replacement after submission of warranty claim.
- 6— The successful bidder shall provide a one (1) year warranty on the workmanship effective after completion of project.

4. I understand that an "affiliate" as defined in Paragraph 287.133(1)(a), Florida Statutes, means:

1. A predecessor or successor of a person convicted of a public entity crime; or
2. An entity under the control of any natural person who is active in the management of the entity and who has been convicted of a public entity crime. The term "affiliate" includes those officers, directors, executives, partners, shareholders, employees, members, and agents who are active in the management of an affiliate. The ownership by one person of shares constituting a controlling interest in another person, or a pooling of equipment or income among persons when not for fair market value under an arm's length agreement, shall be a prima facie case that one person controls another person. A person who knowingly enters into a joint venture with a person who has been convicted of public entity crime.

I understand that a "person" as defined in Paragraph 287.133(1)(e), Florida Statutes, means any natural person or entity organized under the laws of any state or of the United States with legal power to enter into a binding contract and which bids or appeals to bid on contracts for the provision of goods and services let by a public entity, or which otherwise transacts or applies to transact business with a public entity. The term "person" includes those officers, directors, executives, partners, shareholders, employees, members, and agents who are active in management of an entity.
