Minimum Specifications Landfill Compactor with Spreader Blade

1. General:

The specifications are intended to describe a steel-wheeled trash spreader compactor for all season use on materials commonly disposed in Class I and Class III Landfills. The machine must be constructed of all new components, be unused and be the latest production model of the manufacturer. The minimum operating weight must be 80,000 pounds.

2. Engine:

Minimum 350 H.P. Diesel engine @ 2100 RPM, water cooled, 6-cylinder, replaceable element dry type air cleaner with safety element and pre-cleaner.

3. Power Train:

Transmission shall be either a hydrostatic or a powershift drive, with two (2) forward speeds.

4. Electrical System:

24-volt system with minimum 75-amp alternator, operational lights minimum 2 front and 2 rear.

5. Gauges And Indicators:

Shall be provided for all critical system components and safety indicators for the braking system.

6. Engine/Transmission Protection System:

Engine/Transmission protection system designed to warn and shut down engine when engine lube oil pressure is low, engine coolant level is low and/or engine coolant temperature is high, transmission temperature is high or transmission pressure is low. Engine lubricating oil shall be filtered and cooled.

7. Blade:

Blade with trash screen capable of spreading refuse and cover dirt 14', with replaceable cutting edges.

8. Compaction Wheels:

Constructed of steel with staggered chopper cleats welded to the outside drum surface to provide maximum crushing and traction. Inner and outer wheel surfaces and cleats shall be hard surfaced for maximum wear life.

9. Operational Items:

Air-conditioned and heated cab with sound suppression, ROPS, rear view mirrors, best available seat offered by manufacturer. Horn, cab light, fire extinguisher. Outside mirrors, right and left side. Windshield wipers and washers for front and rear windows.

10. Shielding And Protection:

Radiator shall be rear mounted and easily accessible for clean out. Axle and seal guards, crank case and power train guards.

11. Miscellaneous:

Two copies of operator's manual, shop manual, parts manual to be supplied. Parts availability within 75 miles of Milton, Florida. Inventory shall be sufficient size and variety to offer a 95% availability within 48 hours from time of customer order. Normal maintenance items (filters, belts, hoses, etc.) shall not exceed 24 hours. All radiators shall be trash specific, to provide for extra cooling under landfill operations.

Bid price shall reflect a warranty to include parts and materials for five years or 10,000 hours.

Delivery time will be a factor in determining bid award.

4. I understand that an "affiliate" as defined in Paragraph 287.133(1)(a), Florida Statutes, means:
 1. A predecessor or successor of a person convicted of a public entity crime; or
 2. An entity under the control of any natural person who is active in the management of the entity and who has been convicted of a public entity crime. The term "affiliate" includes those officers, directors, executives, partners, shareholders, employees, members, and agents who are active in the management of an affiliate. The ownership by one person of shares constituting a controlling interest in another person, or a pooling of equipment or income among persons when not for fair market value under an arm's length agreement, shall be a prima facie case that one person controls another person. A person who knowingly enters into a joint venture with a person who has been convicted of public entity crime.

I understand that a "person" as defined in Paragraph 287.133(1)(e), Florida Statutes, means any natural person or entity organized under the laws of any state or of the United States with legal power to enter into a binding contract and which bids or appeals to bid on contracts for the provision of goods and services let by a public entity, or which otherwise transacts or applies to transact business with a public entity.
